 - a. Additional instructional aide to be utilized under Title I funding.
 - b. Increase in Special Education costs to service current caseload during the year.
- 5) Page 5 Expenditures continued
 - a. Increase in legal services due to matters regarding COVID new building, and State aid note
 - b. Reductions in School Administration due to reclassification of principal assistant costs to behavioral interventionist.
 - c. Decrease in custodial services due to movement to remote learning environment.
- 6) Net results
 - a. Change in fund balance from 395.00 to a gain of approximately \$10,397.00.
 - b. Projected ending fund balance of \$10,546.00 or approximately 1.6% of unrestricted revenues.

Be it further resolved, that FOR THE PURPOSES OF MEETING EMERGENCY NEEDS of the Academy, transfers of appropriations may be made upon written authorization of the Chief Administrative Officer, without prior approval of the board of directors, provided the transfers are for purposes consistent with those specified within these appropriations. When the Chief Administrative Officer makes a transfer of appropriations as permited by this resolution, such transfer shall be presented to the board of directors at its next regularly scheduled meeting in the form of an appropriation amendment.

Be it further resolved, that the number of authorized positions upon which these appropriations are based shall not be increased or changed without the approval of the board of directors.
