Reconfirmation Meeting for May 25, 2021

Reconfirm instructional delivery method: Hybrid model: Synchronous 'IN PERSON' & 'REMOTE'

On February 22, 2021 Faxon Academy started the hybrid model with students attending 'IN PERSON' or 'REMOTE' based on our student/families preference. All families were surveyed during the week of February 8th, 2021 to select their preference of instructional model. Sixty percent of students will remain 'REMOTE' and 40% are 'IN PERSON.' Our educators provide synchronous instruction to 'IN PERSON and 'REMOTE' students. The Faxon Academy master school schedule continues as developed and implemented since Fall 2020. All students will continue to attend school every day, Monday through Friday. Our Extended Covid-19 Learning Plan is in alignment with the Governor and the Oakland County Health Department guidance.

Faxon Academy has successfully returned to our hybrid instructional model over the last month. This hybrid model mirrored the same model that students experienced in the Fall 2020 prior to going fully remote due to COVID-19 for the months of Mid-November 2020, December 2020, and January 2021. As of March 23, 2021 48% of students will remain 'REMOTE' and 52% are 'IN PERSON.' As of April 27, 2021 36% of students will remain 'REMOTE' and 64% of students are 'IN PERSON." As of May 25, 2021 There have not been any changes to the plan.

All students will receive instruction Monday-Friday per our Phase 4 COVID-19 Plan in a distinct hybrid learning model.
